On 24 January 1819, around the first hour of the afternoon all the church rites were performed and Catharina Nevers, once Weinand and the wife of Francis Neiers of Trintingen, died. She was buried in the parish cemetery the next day.

Maria Welter, the daughter of Martin Welter and Elisabeth Kramer, a married couple of Trintingen, was baptized 3 November 1743. Sponsors were Peter Welter and Maria Welter who was born Conen. On the same day Odilia, another daughter of the couple, was baptized. Sponsors were Adam Ernest and Odilia Knepper who was born Ginot (?).

A 13 January 1743 marriage contract was made by Martin Welter of Trintingen and Elizabeth Kramer from Rerchem (?). This couple were great, great grandparents of Anna Neiers.

On 24 January 1793 Martin Welter, a farmer from Trintingen (Trintange), died at seven in the morning and the next day was buried at nine A.M.

The 6 February 1724 marriage contract of Martin Weinand from Roedt and Anna Thurn of Waldbredimus. They were great, great grandparents of Anna Neiers. A 1760 record shows Martin was a synadolis.
